

Hi Brent-

I have received your application packet for the above referenced retaining wall. It was received at the town office on April 9, 2020. Unfortunately, it is not acceptable for processing and your application and check will be returned to you.

As I told you via email in mid January of this year, a conditional use planning board permit is required for your sheet metal retaining wall. The application fee is \$100. There are also additional costs for abutter notices which we can discuss at a later date. Most importantly, you must submit a complete planning board application (all three attached forms to this email). Once I receive them back from you, I will review and if adequately completed schedule you for the planning board.
